As a Junior Member of the Club I recognise that I am bound by the Junior Club rules and am expected to:

Club Policy on the taking of photos and Videos of Young People playing sport

We are keen to promote positive images of children playing sport and generally do not wish to prevent the use of photographic or videoing equipment. However, we are very mindful of the concerns of parents/guardians in this respect, so it is our club policy that photographs/images will not be taken of a child at matches or training without the prior permission of the parents/guardian.

If press photographers, parents and coaches or managers from our own teams or from opposition teams wish to take photographs or videos, they can only do so with the permission of the coach or manager on the day, and that coach or manager can only give that consent if parents/guardians have previously signed a consent form.

If no consent has been given by parents of individual children, the coach or manager can tell the people wishing to take photographs/videos that they must avoid taking photos of that particular young person. We should stress that it is not our wish to prevent parents from taking pictures of, or filming their children as we recognise that these are normal family practices and help mark milestones in a child's life. However, to cover our best practices and policy we will require the parent's/guardian's consent, using the form below.

We ask Parents and members to be alert for anyone taking inappropriate or intrusive photography and to immediately report any concerns to the team coach or manager who will submit a report to the club's welfare officer.

We have a club website which has the facility to show team photos and photos/videos from matches. Naturally no picture will be shown on the website without the permission of the parent/guardian and young person concerned, and at no time will the picture be allowed to detail the party's name. Naturally all such pictures will show the young person in the relevant sporting gear.

We also use social media platforms (Facebook, Twitter, Instagram and YouTube) to promote our club and we increasingly post photos/videos from matches on these. We will often tag national and local sports bodies and opposition teams in such posts.
